As our pillars state: we Live with Character, Feel with Empathy, and Act with Passion. A key way we bring these values to life is through our CDFI (Community Development Financial Institution) status. This commitment allowed us to provide over 3,700 loans last year to low-income and CDFI-area residents. Among those loans, we offered more than a half million dollars in Fresh Start Loans for members who might not have qualified due to past credit challenges, helping them rebuild their financial future and achieve their goals.

Alongside our CDFI initiatives, we remain committed to purposeful volunteerism and charitable giving. This past October, our entire workforce participated in a "Zeal the Love" Day of Service at Gleaners Community Food Bank. Together, we packed over 26,000 pounds of apples and 17,000 pounds of corn to help ensure our local food pantries were stocked with nutritious options. Our Southgate branch organized a drive to collect Thanksgiving turkeys and sides, donating them to Downriver for Veterans: an organization promoting the well-being of our nation's veterans. We also donated more than \$25,000 to local schools, sports teams, and charitable organizations, including Forgotten Harvest, a middle school Robotics Team, and Children's Miracle Network, reinforcing our commitment to supporting the communities we serve.

OVERSIGHT COMMITTEE

The Oversight Committee ensures that the Credit Union's financial records are accurately maintained. We work closely with our CPA firm to provide an independent audit of the financial statements for the membership. The audits are conducted in accordance with generally accepted accounting principles and standards. The reports critically and systematically examine the internal controls, statements, records, accounting transactions and other financial records of the Credit Union. The CPA firm issued their opinion that the financial statements present fairly, in all material respects, the financial position of the Credit Union, in conformity with accounting principles generally accepted in the United States of America. In addition, the Oversight Committee oversees the internal audit function and reviews internal audit reports.

The State of Michigan Department of Insurance and Financial Services also conducts periodic examinations of the records of the Credit Union. The results of each examination are reported to the Board of Directors and the Oversight Committee. In addition to these safeguards, the National Credit Union Administration (NCUA), an agency of the U.S. government, insures deposit accounts of the Credit Union to at least \$250,000.

TREASURER'S REPORT

Zeal Credit Union has continued to grow and ended 2024 with \$825,402,713 in Total Assets. The credit union's capital position has improved to a 20.7% Net Worth ratio built by driving organizational efficiencies leading to a solid Net Income.

Zeal's lending program continues to deliver high quality results with \$240 million in loans granted throughout 2024. From providing debt consolidation relief, to assistance with purchasing a new vehicle, and supporting local small businesses, Zeal continues to serve our members in ways to help them be financially successful.

Zeal Credit Union will continue to strengthen the financial futures of the hardworking Americans Zeal serves and help Zeal members build their dreams into reality. Southgate Anderson High School


- Logan plans to attend Wayne State University and study Political Science and Law.
